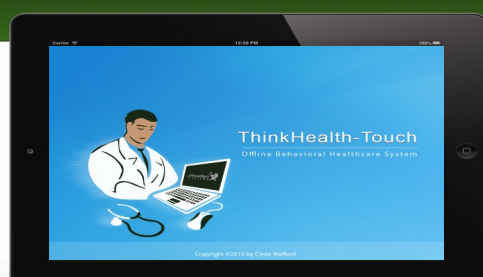

## Improper Medicare payments drop by nearly \$5 billion

The CMS on Tuesday unveiled that the number of improper payments doled out by Medicare is the lowest it's been since 2013, accounting for less than 10% of overall Medicare payments.

All in all, the CMS estimated that improper payments dropped \$4.9 billion from 2016 to 2017, marking a rate decrease from 11% in 2016 to 9.5% in 2017.

Improper payments include fraudulent claims, payments distributed to the wrong recipient or for the wrong amount, payments with insufficient documentation and issues where the recipient uses the funds improperly.

The CMS calculations include all claims incorrectly paid between July 1, 2015, and June 30, 2016. This is the first time since 2013 that the Medicare fee-for-service improper payment rate is below 10%, according to the agency.

## Frequently Asked Questions about Oklahoma's Special Session

Although the Oklahoma Legislature has convened numerous special sessions in recent decades, none has dealt with issues as sweeping and consequential as the current one. This set of Frequently Asked Questions is intended to help Oklahomans understand the rules guiding the process and the issues being addressed. It will be updated regularly as the session continue.

After the failure of the comprehensive budget plan in Week 7, House and Senate leaders began to move forward with a [new budget](#) that relied on some \$140 million in additional cash, a higher gross production tax on "legacy wells," and cuts of up to 2.44 percent on most agencies to fill the \$215 million shortfall. (See our statement on the plan [here](#).) A new General Appropriations bill, [HB 1019X](#), along with several other budget bills, narrowly passed out of House and Senate committees Tuesday. It passed the full House, 56-38, on Wednesday and is scheduled to be heard by the full Senate on Friday. [Click here](#) for agency-level appropriations under HB 1019.

## Adults With Disabilities Advocates To Rally At State Capitol

## State House Passes Budget Bill

The state is one step closer to bridging a \$215 million budget gap.

The State House of Representatives passed a bill today that would take money from several state funds, make targeted cuts, and raise the tax on oil and natural gas production. It does not include raises for teachers and state workers.

Lawmakers aren't happy. Last week they were told they had to pass the largest tax increase in state history, or services for thousands of Oklahomans would be cut. Now they're being told the state had the money to fund services all along.
