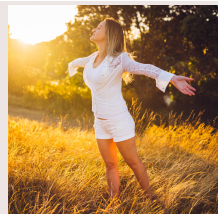
APA WF 22-16 Statewide Health Information Exchange (HIE)

The proposed revisions will update policy to comply with OK Senate Bill 1369 which made changes to the statewide Health Information Exchange (HIE). The proposed revisions include repealing all previously approved language; adding the Office of the State Coordinator for HIE; designating that the Office of the State Coordinator for HIE will oversee the state-designated entity for HIE; and revising the definition of "health information exchange organization" to indicate that it is an organization governed by its stakeholders.

2024 Medicare Advantage and Part D Final Rule (CMS-4201-F)

The Centers for Medicare & Medicaid Services (CMS) issued a final rule that revises the Medicare Advantage (MA or Part C), Medicare Prescription Drug Benefit (Part D), Medicare Cost Plan, and Programs of All-Inclusive Care for the Elderly (PACE) regulations to implement changes related to Star Ratings, marketing and communications, health equity, provider directories, coverage criteria, prior authorization, network adequacy, and other programmatic areas. This final rule also codifies regulations implementing section 118 of Division CC of the Consolidated Appropriations Act, 2021, and section 11404 of the Inflation Reduction Act, and includes provisions to codify existing sub-regulatory guidance in the Part C, Part D, and PACE programs.

Landmark Ohio Study Will Evaluate Racial and Ethnic Disparities in Behavioral Health Care

Conducted by Central State University, the Mental Health and Addiction Advocacy Coalition, the Multiethnic Advocates for Cultural Competence Inc. and Ohio University, the study cites national research identifying stigma when seeking help for mental health or addiction, provider racial bias and lack of access to culturally competent care as ongoing problems for minorities.

Governor Announces \$2.9 in Federal Funding to Strengthen Emergency Preparedness, Enhance Behavioral Health Response Following Traumatic Events

Ohio Governor Mike DeWine today announced that the Ohio Department of Mental Health and Addiction Services (OhioMHAS) has been awarded nearly \$2.9 million in federal funding from the Bipartisan Safer Communities Act to help state officials meet the behavioral health needs of citizens affected by traumatic events such as natural disasters, mass shootings, and other large-scale man-made and terrorist events.
