National Council Pilots Models for Primary Care

The National Council for Behavioral Health has announced an educational program with support from Kaiser Permanente for community health centers to become trauma-informed practices and models for replication.

"Most people will see a primary care doctor before they will see a mental health or addiction professional," said Linda Rosenberg, president and CEO of the National Council, in a statement. "They are our frontline to mitigating trauma's affect on all of us. Kaiser Permanente's investment in this space will expedite primary care settings' adoption of trauma-informed practices, which we know is the foundation of healing and recovery."

How Colleges Can Better Serve Those in Recovery

I ran the Recovery House at Rutgers for five years and also worked in the counseling centers in two locations. The center in Newark served a campus with 13,000 students and had four full time clinicians and another six part time ones. The New Brunswick center served a campus of 55,000 and had about 40 clinicians, most of whom were full time.

Midway through the fall semester each year, I would meet students who were struggling with mental health and/or substance use disorders that had left an inpatient treatment center in late August and promptly enrolled in school on September 2. They did so either on their own or at their families' behest.
