Majority of Americans willing to share health data

Would the response be different when it comes to sharing behavioral healthcare data? Tami Mark, PhD, vice president and director, Center for Behavioral Health Services Research, Truven Health Analytics, says possibly.

"People with mental health and substance abuse conditions are concerned that if they share information about their conditions with medical providers that they will be stigmatized. Unfortunately, this is a valid concern," she says. "Research shows that providers tend to discount the symptoms reported by people with mental health and substance abuse conditions. This is also tragic because people with severe mental illness die 25 years earlier than other individuals because of untreated or poorly treated medical conditions such as heart disease and diabetes.

Outpatient BH Agencies Accreditation Requirement

Behavioral Health Providers, in order to be qualified to render SoonerCare covered services, outpatient behavioral health agencies must be accredited as a provider of outpatient behavioral health services from one of the national accrediting bodies or certified by the Oklahoma Department of Mental Health and Substance Abuse Services (ODMHSAS). This is pursuant to <u>OAC317:30-5-240.2</u>. Therefore, effective January 1,2015, the Oklahoma Health Care Authority (OHCA) will no longer contact with agencies that have anything less than full accreditation for the line of service for which they are seeking to contract.

OHCA is notifying providers of this change so that agencies do not allow an existing accreditation/ certification to expire with the expectation of switching to a different type of accreditation/ certification using the provisional option for temporary operation.

For each regulation, there is typically a comment period where the issuing agency seeks public input on the proposed content of the regulation.
