LPC/LMFT Board Proposed Rule Change

OrionNet Systems' has learned about a week ago that the board for the LPC's and LMFT's are proposing new rules that would no longer allow Candidates to provide services in schools or home based unless their license supervisor was on site with them . The rationale is that a Candidate should have immediate access to their supervisor for consulting on difficult cases. I have already written to the board members to express concern for this lack of logic and how damaging it could be to hundreds of Candidates working across the state.

The board is set to meet on Friday and the agenda will come out on Wednesday. It is important they hear from as many people as possible. If it does show up on the agenda Wednesday, I will be going to the board meeting in OKC at 10 on Friday. Anyone who is affected by this or feels strongly about it is welcome to go as well. I may be going up Thursday night to meet with a couple of others I am working with to get the word out so you would need to plan transport with others etc.

This issue would affect several of our current staff. Fortunately we have several who are close to being done that I don't think it would affect. In general, it's just a bad rule because any Candidate should be able to call their supervisor anytime just as they would if they were in the same building together.

Gov. Fallin Forms Task Force to Review Occupational Licensing **Requirements**

The Oklahoma Occupational Licensing Task Force will provide recommendations to the governor to remove unnecessary or burdensome regulations that are a barrier to potential workers.

"Occupational licensing often can be overly burdensome, which can hinder a person from earning a living and providing for their family," said Fallin. "These unnecessary or outdated barriers make it harder for many Oklahomans, particularly those who may not have completed a formal education as well as some minorities. This can help them to obtain jobs and build new businesses that create jobs."

U.S. Sues Mississippi Over 'Discriminatory' Mental Health **System**

The Justice Department sued Mississippi A few days after Donald J. Trump was on Thursday, accusing it of using elected president, I started getting segregated state-run hospitals to warehouse mentally ill people who could thrive in the community, instead.

The suit, filed in U.S. District Court in how they were going to fare, given their Jackson, alleges that the state — whose longstanding and serious mental budget crisis has led to deep cuts for the illnesses. state Department of Mental Health refuses to provide adequate communitybased services, unnecessarily forcing "hundreds of people a day" to enter the state's four mental institutions, which it described as illegally segregated.
